



INTERNATIONAL STUDENT FINANCIAL CERTIFICATE

All international *undergraduate* applicants for the 2012-2013 academic year are required to certify that the sum of U.S. \$44,652 (includes tuition and fees, room and board, meal plan, technology package, books and supplies, and miscellaneous living expenses) will be available during the first academic year of study (September through May), not including travel expenses.

All international *graduate* applicants for the 2012-2013 academic year are required to certify that the sum of U.S. \$29,682 (includes tuition, living expenses and technology package fees) will be available during the first academic year of study (September through May).

Applicants also must indicate how they will meet expenses for subsequent years of study. Estimates of support for second, third and fourth years of study should be based on first-year expenses (\$44,652) for undergraduate students and \$29,682 for graduate students.

Students holding F-1 visas will not be authorized to work except under extraordinary circumstances and with government approval. Employment, either part time during the academic year or full time during the summer, should not be considered a means of support while attending MSOE. Under no circumstances are international students permitted to work full time during the academic year.

Married students who plan to bring a spouse and/or children must certify a proportionately larger amount of finances on the basis of at least an additional \$4,500 per year (\$375 per month) for a spouse and \$2,400 (\$200 per month) for each child. F-2 visa holders (dependents of an F-1 visa holder) are not permitted to work under any circumstances.

A copy of this and other financial documentation may need to be provided to the United States Consulate/Embassy officials at the time of visa application.

Please Note: *Milwaukee School of Engineering does not issue Form IAP-66 for obtaining the J-1 (exchange visitor) visa. A Form I-20 (certificate for eligibility for F-1 visa) cannot be issued to you until you have been admitted to MSOE and have completed this form to our satisfaction and returned it to the following address:*
